PARLIAMENTARY BOUNDARIES REVIEW OF THE ISLE OF WIGHT

It only remains now for the Boundary Commission to determine how the Island will be divided into two constituencies.

Bob Blezzard has worked on this and will be outlining his thoughts at our next 'Island Forum' due to take place on Saturday 16th April at the Riverside Centre (10-30am).

From this meeting the Island Lib Dem Executive will be making a recommendation to the Region who will pass this on to the Federal Party from where the proposals will go to the Boundary Commission.

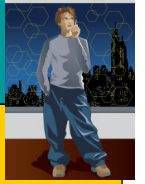

NEWS FROM THE IOW COUNCIL CHAMBER

THE IMPENDING DEMISE OF OUR ISLAND YOUTH SERVICE

Reg Barry introduced two amendments to the Budget proposed by the Independent Councillors. Needless to say there was no chance of these amendments getting through but Reg showed that there were options to closing front-line services.

The PFI for the improvement and maintenance of our highways infrastructure continues to be of major concern to the Lib Dem Group who fear that costs associated with setting up and administration this scheme are running out of control. Indeed there remains serious doubt whether the PFI will ever come to fruition yet the costs continue to escalate.

Reg wanted the PFI scheme to be reviewed to enable spiralling costs to be reined in, additionally, the Lib Dem team wanted the investment in our highways infrastructure to be brought up to the levels in place before the Tories got into power. Such a move would halt the deterioration in our highways. Neither amendment was approved by the Tory dominated council.

A further amendment, tabled by Lib Dem Cllr Dave Knowles and supported by the Independent Group, was for the Waterside Pool in Ryde to remain open and for the savings required to be shared between all the sports and swimming pools—this realistic and achievable idea was dismissed 'out of hand' by the ruling Tory Group.

On April the 12th (unless it is delayed yet again) IOW Councillors will vote to support the Draft Plan for the future of the Island Youth Service.

This Plan, born of a flawed consultation process and over two years in gestation puts the IOW Council at risk of failing in its statutory duty to young people.

The Plan proposes the closure of most Island Youth Centres and fails to say how many young people will be reached by the new service or what the benefits and outcomes will be.

Please contact your local councillor and ask that they reject the inadequate Draft Plan as being unfit for purpose.
